Swift secures 5-year Shell Prelude LNG services contract ASX: SW1

At Prelude, Shell is developing the world's largest offshore floating facility to produce LNG at sea and the facility will include all the necessary accommodation to house its workforce.

It is anticipated that through the 5.3 million tonne per annum facility, Shell and its partners will spend at least the next 20 years developing the gas fields approximately 475 kilometres northeast of Broome in Western Australia.

- Wireless Internet via Nextgen subsea optical fibre cable
- Custom alerting and messaging, with connection to public address and general alarm (PAGA) systems for extending communication to all screens in the event of an emergency
- Wellbeing and Corporate information channels
- Ongoing maintenance and support with 24x7 helpdesk
