## Subscription renewals totalling \$1.3 million for Roy Hill and Pilbara Minerals

Swift's long standing clients Roy Hill and Pilbara Minerals have renewed their Swift subscriptions for a further 12-month period with a total contract value of \$1.3 million.

Roy Hill was the first major mining site to implement Swift Access with our unique low bandwidth entertainment feature, that includes an early release window for on-demand movies, communication tools to streamline essential communications to remote workforces and secure casting, at their main personnel village in 2022.

Roy Hill will also be the first Swift client, within the Mining and Resources sector to roll out the next generation of Swift Access (Swift Access 2025) which features a new user interface and user experience that positions Swift Access at the forefront of Entertainment and Engagement solutions designed for commercial environments. The roll out at Roy Hill will commence later this month.

With a dynamic lithium market currently in a challenging cycle, Pilbara Minerals has renewed its agreement with Swift. This renewal will include the continuation of Swift subscription and support services for 12 months, ensuring reliable village entertainment services for their remote workforces.

Whilst the aggregate revenue from these contracts is material to the Company, no individual agreement generates over \$1.0 million in revenue.
