## Swift signs \$2.4 million Chevron Contract

- **\$2.4 million renewal agreement with Compass to deliver Swift Services to three Chevron sites for 12 months.**

The renewal agreement signed with Compass Group is for Chevron's Gorgon Butler Park, Wheatstone Onshore, and Wheatstone Offshore facilities.

This contract comprises Swift's 24/7 technical support and entertainment services. The Total Contract Value of the 12-month term is \$2.4 million, OPEX revenue commenced in May 2025.

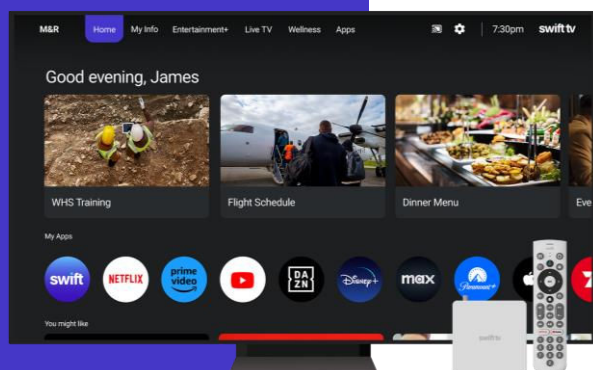
